Proviso to Rule 19A(5) of the Securities Contract (Regulations) Rules, 1957 provides that every listed company shall maintain public shareholding of atleast 5% as a result of resolution plan approved under section 31 of IBC. The said rule further provides that if the public shareholding falls below 10% the same shall be increased to 10% within 12 months and 25% within 36 months from the date such fall.
