

## Dera followers begin to vacate sect headquarters

Sirs

Dera Sacha Sauda followers today started leaving the sect's headquarters in Sirsa, where they had gathered in large numbers before the rape conviction of self-styled godman Gurmeet Ram Rahim Singh, a senior police officer said.

The police and the administration have been making regular announcements through loudspeakers, urging those inside to vacate the sprawling premises, even as they kept a close watch on proceedings.

"Dera followers are leaving the headquarter campus in small groups. We hope it will be vacated peacefully," DSP, Sirsa, Dilip Singh told PTI. The violence following conviction of the Dera head Gurmeet Ram Rahim in a rape case, by a special CBI court in Panchkula, resulted in four deaths and injuries to 58 Dera followers in Sirsa.

The Army, along with the police and paramilitary forces, has put up barricades at entry points of the Dera prem-

ises. "There is no plan so far to enter the Dera headquarters here. We are focusing on maintenance of law and order presently," GOC, 33 Armoured Division, Maj General Rajpal Punia said in a media briefing.

Curfew has been clamped in the town and the situation is being closely monitored by the police, army and paramilitary personnel, officials said.
