MUCH AWAITED MEETING | Hungary stays away

Ahead of Don-Putin meet, 26 EU leaders back Ukraine

IANS BRUSSELS

As many as 26 leaders of the European Union issued a joint statement on Monday, highlighting their support for Ukraine ahead of the muchawaited meeting between US President Donald Trump and his Russian counterpart Vladimir Putin in Alaska on August 15. Hungary Prime Minister Viktor Orban, however, decided to not support the statement, citing reserva-

tions about the idea. In the statement, drafted by EU Council president Antonio Costa, the European leaders said that a "just and lasting peace" must uphold Ukraine's independence, sovereignty and territorial integrity, stressing that borders "must not be changed by

The EU leaders welcomed Trump's efforts towards "ending Russia's war of aggression" against Ukraine and achieving a just and lasting peace and security for Ukraine. They stated that a lasting peace is required with respect for international law,



The path to peace in Ukraine cannot be decided without Ukraine. Meaningful negotiations can only take place in the context of a ceasefire or reduction of hostilities

During the past two days, the European Union has made a push for inclusion of Ukrainian President Volodymyr Zelensky in the talks, Euro News reported. Any diplomatic solution, they said, must protect the security interests of Europe and

In the statement, the EU leaders hinted that the bloc is ready to provide further political, financial, and military support to Ukraine for its self defence and demanded security guarantees for wartorn nation. Furthermore, the leaders expressed support for Ukraine's path towards EU

Meanwhile, Hungary said that it "does not associate itself" with the statement.

"Just four days ahead of the historic summit between President Trump and President Putin, the European Council sought to issue a statement in the name of all EU heads of state and government. Before the liberalmainstream chorus begins its newest rendition of their favourite 'Putin's puppet' tune, I decided to share why I could NOT support the statement on behalf of Hungary," Hungarian Prime Minister Viktor Orban posted on X.

Orban stated further: "The statement attempts to set conditions for a meeting to which leaders of the EU were not invited. The fact that the EU was left on the sidelines is sad enough as it is. The only thing that could make things worse is if we started providing instructions from the bench. The only sensible action for EU leaders is to initiate an EU-Russia summit, based on the example of the US-Russia meeting. Let's give peace a chance!"

An earthquake of magnitude 6.3 rattled Indonesia on Tuesday, a statement by the National Center for Seismology (NCS) said. As per the statement, the earthquake took place at a depth of 39km. In a post on X, the NCS said, "EQ of M: 6.3, On: 12/08/2025 13:54:27 IST, Lat: 2.09 S, Long: 138.81 E, Depth: 39 Km, Location: West Papua Indonesia." Earlier on August 7, another earthquake of magnitude 4.9 on the Richter Scale occurred at a depth of 106km.

Heavy rains kill three in **Kyushu**

Record-breaking rainfall caused by a seasonal front hit Japan's Kyushu region on Tuesday, resulting in three confirmed deaths in Kagoshima, Kumamoto, and Fukuoka prefectures, local media reported. Local authorities reported that the victims were caught in landslides and river flooding, according to national broadcaster NHK. In addition, a road collapse caused a vehicle to fall, injuring three people in Ishikawa Prefecture, Xinhua news agency reported. Emergency crews are continuing rescue and recovery operations as heavy rain warnings remain in effect, according to report. At least two people were also feared dead and several others remained missing in southwestern Japan on Monday as heavy rain continued to hit the region, sparking floods and landslides.

Iran says it detained 21K suspects during the June war with Israel

TEHRAN

Iran's police detained 21,000 suspects during the 12-day air war between Israel and Iran in June, state media reported on Tuesday. A report by state TV quoted a police spokesperson, Gen Saeed Montazeralmahdi, as saying people reported the suspects to the authorities. "The arrest of 21,000 suspects during the 12day war indicated high awareness and participation of people in providing security," he said.

UN-backed investigators allege sex crimes in Myanmar detention facilities

GENEVA

A UN-backed investigator says his team has turned significant evidence "systemic torture" Myanmar's detention centres, including electric shocks, strangulations, gang rape and burning of sexual body parts over the last year.

Nicholas Koumjian was speaking as the international independent team he heads released its latest annual report on Tuesday, focusing on a oneperiod through June 30.

Myanmar has been in turmoil since the army seized power from the elected government of Aung San Suu Kyi in February 2021, triggering a civil war. After peaceful demonstrations were put down with lethal force, many opponents of military rule took up arms, and large parts of the country are now embroiled in conflict.

Russian army not preparing to end war, says Zelensky

Ukrainian President Volodymyr Zelensky on Tuesday said that the Russian army is "not preparing to end the war" in Ukraine and is instead making movements that indicate preparations for new military operations. The comments came ahead of meeting between the US President Donald Trump and his Russian counterpart Vladimir Putin in Alaska on August 15.

Zelensky expressed support for Trump's determination but, at the same time, called for taking positions that will not allow



Russia to "deceive the world". He called for putting pressure on

Moscow until it continues its military action in Ukraine. Zelensky, who has over the past few days spoken to several world leaders, including Prime Minister Narendra Modi, also expressed gratitude to the European Union leaders for their support of Ukraine's independence and territorial integrity.
