

Sub: Consolidated Scrutinizer's Report on remote e-voting and postal ballot process conducted pursuant to provisions of Section 108 and 110 of the Companies Act, 2013 read with Rule 20 and 22 respectively of the Companies (Management and Administration) Rules, 2014as amended of Equity shareholders of the company.

Dear Sir,

I, Ashish Karodia, Practising Company Secretary (Membership No. FCS 6549 & CP No. 6375) having my office at 208, 14/3, South Tukoganj, Indore 452001, have been appointed as a Scrutinizer of Ujaas Energy Limited("the Company") having "CIN-L31200MP1999PLC013S71pursuant to provisions of Section 108 and 110 of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 as amended to conduct thee-voting through National Securities Depository Limited ("NSDL")(EVEN108186) and postal ballot conducted for public only as per SEBI circular bearing no. CIR/CFD/CMD1612015 dated November 30, 2015 for the Equity shareholders of the company on resolution seeking shareholders approval in respect of the below mentioned resolution.

#### 1. Re-classification of promoter and promoter group.

I was also appointed as the Scrutinizer to scrutinize the postal ballot/e-voting process in fair and transparent manner.

The Notice dated 13th February, 2018 was dispatched on 16th February 2018along with the statement setting out material facts under Section 102 of the Act, ballot forms and self-addressed postage business reply envelope to its member whose names appeared on the register of members/list of beneficial owner as on the cut off date i.e. 9th February 2018.

The Company has availed the remote e-voting facility offered by NationalSecurities Depository Limited(N\$DL) for conducting e-voting by the shareholders of the Company.

Pursuant to Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 an advertisement was published by the company in Free Press, Indore editiondated 17th February 2018 and in the Chalutha Sansar, Indore edition dated 17th February 2018 informing the completion of dispatch of notices along with other related matter mentioned therein.

The voting period for e-voting commenced on Monday, 19th February, 2018from09.00 e.m. and ended on Tuesday, 20th March, 2018 at 5.00 p.m. and the NSDL e-voting platform was blocked thereafter.

After the closure of the e-voting, report on voting was generated in my presence and the same was diligently scrutinized.

The votes cast under e-voting facility were thereafter unblocked in the presence of 2 witnesses who were not in the employment of the Company and after the closure of remote e-voting the votes cast thereunder were counted.

I have scrutinized and reviewed the e-voting and votes tendered therein based on the data from the National Securities Depository Limited (NSDL)e-voting system and voting by postal ballot.

I now submit my consolidated report as under on the results of the e-voting and voting by postal ballot in respect of the said resolutions.
